



## Academic Review Guidelines for Academic Turnaround Program Outcomes, COVID Response

**Please review your signed ATP Advising Form prior to reading this document.**

<b>Student Scenario</b>	<b>Outcome</b>
Student successfully completed appropriate F19 courses with over a 2.0 GPA. Student successfully completes W20 courses with letter grades or CR in W20 semester.	Student is moved to good standing (file will read CLRD meaning cleared probation).
Student successfully completed appropriate F19 courses with over a 2.0 GPA. Student is not successful in 1+ W20 course.	Student continues on probation (and remains on ATP) for F20/W21.
Student successfully completed appropriate F19 courses with 1.7 GPA < 2.0. Student successfully completes W20 course work with letter grades bringing overall review GPA to a 2.0 or higher.	Student is moved to good-standing ruling (file will read CLRD meaning cleared probation).
Student successfully completed appropriate F19 courses with 1.7 GPA < 2.0. Student successfully completes W20 course work with CR grades.	Student continues on probation (and remains on ATP) for F20/W21.
Student successfully completed appropriate F19 courses 1.7 GPA < 2.0. Student is not successful in 1+ W20 course.	Student continues on probation (and remains on ATP) for F20/W21.
Student did not clear one or more of the required F19 courses as outlined in their ATP Advising Form. Student successfully completes W20 courses with letter grades or CR.	Student will be required-to-withdraw unless they have already brought forward mitigating circumstances for the F19 semester.
Student did not clear one or more of the required F19 courses. Student was not successful in 1+ W20 courses.	Student is required-to-withdraw unless they have already brought forward mitigating circumstances for the F19 semester.
Student did not register in all of the required ATP courses in F19 or W20 as outlined in advising form. Student successfully completes all registered course work for F19. Student is successful in W20 courses.	Student continues on probation <i>with caveat that the must prioritize and complete missing requirements as soon as possible</i> . If student did not respond to urgent meeting requests to

	address registration issues student may receive required-to-withdraw ruling.
Student did not register in all of the required ATP courses in F19 or W20. Student successfully completes all registered course work for F19. Student is unsuccessful in 1+ W20 courses.	Student continues on probation (and remains on ATP) <i>with caveat that they must prioritize and complete missing requirements as soon as possible</i> . If student did not respond to urgent meeting requests to address registration issues student may receive required-to-withdraw ruling.
Student did not register in all of the required ATP courses in F19 or W20. Student was unsuccessful in 1+ F19 courses. Student may/may not have completed W20 courses.	Student is required-to-withdraw unless they have already brought forward mitigating circumstances for the F19 semester.
Students who requested time-off through their success plan application in W19.	Continue into their studies for F20 as normal on ATP.
